JOB OPPORTUNITY

Open Call on competitive basis at the **FUNDACIÓN PARA LA INVESTIGACION BIOMÉDICA DEL HOSPITAL CLÍNICO SAN CARLOS-IdISSC** for a position as **Scientific Support Staff** (Área 2 – Grupo II - Titulado Superior) at the Endocrinology of Metabolic Diseases Research Group, for the following project funded by ISCIII and Co-funded by European Union –Proyectos de colaboración Internacional de la convocatoria 2023 de la Acción Estratégica de Salud, project: “La edad vascular como clave para un abordaje en equipo del manejo de la presión arterial y el riesgo cardiovascular entre Farmacias Comunitarias y Centros de Atención Primaria”. Reference number AC23_2/00037. The position will be located on Instituto Pluridisciplinar UCM.

Full-time contract (37.5 hours per working week).

The starting date will be on January after resolution and the duration of the contract will be 24 months approximately or when funds allocated to this project are completely expended or the end of the project. Gross salary per year 27.596€ (in 12 payments) approximately in accordance with Spanish Law.

JOB DESCRIPTION/RESPONSABILITIES

- Protocol monitoring; Visiting community pharmacies and primary care physicians at health centers before, during, and after the trial for coordination of patient management; Participation in patient training sessions; Checking and ensuring correct and complete recording of patient data to be included in the study; Collection, evaluation and analysis of blood pressure and vascular age data of participating patients; Collection of surveys on physician-pharmacist coordination, both in pharmacies and health centers.

EDUCATION AND TRAINING REQUIREMENTS

- Master's degree in Medical Sciences or other health sciences (EQF LEVEL 7- Nivel Mecas 3).

When applying, applicants will accept total compliance with the job offer and will be fully responsible for the accuracy of the information submitted. The applicants must provide the following related documents (if they are requested by the FUNDACIÓN): National Identification Number/Passport; original and/or certified copy of University Degree or any other merit mentioned.

SELECTION CRITERIA

Candidates are evaluated applying principles of equality, not discriminating in any way for reasons of sex, age, ethnic, national or social origin, religion or belief, sexual orientation, language, disability, political opinions, and social or economic status. Available OTM-R policy [here](#).

In the event of a tie between two or more candidates, once the score of the different candidatures presented has been calculated in accordance with the punctuation established in each call and with the principles of equality, merit and capacity, the sex less represented in the Unit / Group in question will be prioritized. In the case of gender equality, the candidates who have legally recognized some degree of disability will be prioritized.

Candidates will be evaluated by a designated Evaluation Committee (only if they meet the Education and Training Requirements). This Committee will act in accordance to the following criteria:

A) Merit expertise:

1. Academic background (0-2 points)
 - a) Master's degree in Medical Sciences: 1 point
 - b) Master's degree in other health sciences: 0.5 point
 - c) Outstanding bachelor's and/or master's degree grades (average higher than 8/10 or equivalent): 0.25 points
 - d) Other degrees: 0.25 points
2. Professional experience in the area. Relevant work experience (minimum 3 months) (0-2 points)
3. Research experience (0-2 points)
 - a) Participation in research projects: 1 point
 - b) Scientific publications in indexed journals: 0.5 point
 - c) Communications to congresses: 0.5 points.
4. Grants and mobility (0-2 points)
 - a) Obtaining competitive grants: 1 point.
 - b) Participation in academic exchanges or international programs: 1 point.
5. Specialization courses and additional training (2 points)
 - a) Relevant courses in statistics or data analysis: 1 point.
 - b) Other courses in medical areas or related sciences: 1 point.

B) Job Interview (only if you overcome 5 points at A) Merit Expertise. Previous labour mobility and personal experience, including the experience obtained in non-standard or informal ways, will be assessed. In order to the candidate might be proposer, the overall sum of the marks for all award criteria should exceed 50 %. (0 to 5 points).
